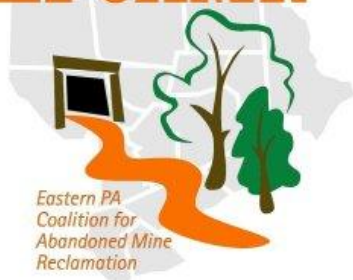

## Eastern PA Coalition for Abandoned Mine Reclamation 2010 Membership Application/ Renewal

This is the time of year when we write to ask for support of activities here with the Eastern PA Coalition for Abandoned Mine Reclamation. EPCAMR is a regional nonprofit 501 (c) (3), public, charitable organization that was organized in 1995 to support and coordinate the efforts of local watershed organizations, community groups, municipal governments, and conservation districts.

For more than a decade, EPCAMR has come to represent the interests of community & environmental organizations, reclamation-related groups, and conservationists alike on abandoned mine reclamation issues. Through persistent outreach and strategic partnerships, EPCAMR has provided opportunities throughout the region for watershed coordination, oversight on AMD/AML construction projects, technical support, funding, scholarship and internship opportunities, environmental education efforts, GIS mapping for local governments and conservation districts, and grant writing assistance.


Pennsylvania holds a legacy of approximately two hundred thousand acres of abandoned mine land (AML) scarred by past mining practices, and over four thousand miles of rivers and streams polluted by abandoned mine drainage (AMD). In the face of these challenges, the success of partnerships with your organizations has been especially encouraging. We have been able to encourage the reclamation and reuse of thousands of acres of abandoned mine lands, creation of jobs from mine land redevelopment, the increase the local tax base, and restoration of miles of once-polluted streams to again hold viable fish populations. These accomplishments reinforce our collective will to reclaim AML through active partnerships today, for a cleaner, sustainable environment for our children tomorrow.

The EPCAMR Program Staff, including two full-time paid positions, are always available for your questions, concerns, requests for technical assistance, and thoughts on issues in AMD/AML-affected northeastern PA. These efforts do not have to be coal-related. Open to all individuals; Student Members shall serve in an advisory (non-voting) capacity to the Board of Trustees of EPCAMR and may serve on one or more committees of the Coalition
- INDIVIDUAL (GENERAL) -** \$10.00       **LIFETIME INDIVIDUAL- \$100.00**  
Open to all individuals; Individual Members shall serve in an advisory (non-voting) capacity to the Board of Trustees of EPCAMR and may serve on one or more committees of the Coalition.
- WATERSHED ASSOCIATIONS & NON-PROFIT ORGANIZATIONS -** \$50.00  
Open to all groups within the EPCAMR Region who would like to become involved with EPCAMR. Groups that join will be considered Affiliate Organizations and their chosen representatives shall serve in an advisory (non-voting) capacity to the Board of Trustees of EPCAMR and may serve on one or more committees of the Coalition.
- CONSERVATION DISTRICTS-** \$50.00  
Open to all Conservation Districts within the 16-County EPCAMR Region; CDs that join are considered Sponsoring Organizations and, as such, may nominate up to **3** representatives to the Board of Trustees of EPCAMR who shall become voting members.\*\*
- INDUSTRY / BUSINESS-** \$100.00 minimum  
Open to all industries such as Coal Companies, Quarries, Power Companies, Co-Generation Plants and their associations (e.g. Pennsylvania Anthracite Council, Pennsylvania Coal Association, ARRIPA) or other mining and reclamation-related businesses (e.g. Consulting and Engineering Firms); Industry Groups that join are considered Sponsoring Organizations and, as such, may nominate **1** voting member\*\* to the Board of Trustees of EPCAMR. Business Members may serve in an advisory (non-voting) capacity to the Board of Trustees of EPCAMR and may serve on one or more committees of the Coalition.

- Legislative updates and action notices, liaison services to government (state, federal or local) abandoned mine reclamation and clean water programs
- Technical grant writing assistance, regional coordination of projects
